

THE ARKANSAS ABORTION AMENDMENT OF 2024

The Arkansas Abortion Amendment is a proposed constitutional amendment more extreme than *Roe v. Wade*. The amendment prohibits the State of Arkansas from restricting, penalizing, prohibiting, or delaying abortion during the first 20 weeks of gestation or the first five months of pregnancy.

The amendment permits abortion at any time during all nine months of pregnancy if there may be risks to a woman's life or health or in cases of rape, incest, or a possibly-fatal fetal anomaly. If passed, the measure would enshrine abortion in the Arkansas Constitution. Since the U.S. Supreme Court overturned *Roe v. Wade* in June of 2022, abortion has been prohibited in Arkansas except to save the life of the mother in a medical emergency. The amendment automatically nullifies all laws and constitutional amendments that conflict with it.

Supporters of the amendment must gather over 90,000 petition signatures by July 5, 2024, in order to be eligible for the November General Election Ballot.

Who is Behind the Arkansas Abortion Amendment of 2024?

Arkansans for Limited Government is a Ballot Question Committee formed in conjunction with **For AR People** to work for the passage of the abortion amendment. **For AR People** are the same people who promote abortion, oppose educational choice, oppose the removal of obscene library books, support critical race theory, and oppose religious freedom protections. They favor affirmative action, support sex-change procedures on minors, promote drag queen story hours for our children, oppose requiring people to use the restroom of their biological sex, and oppose a monument on the state capitol grounds in memory of aborted babies.

When they say that abortion is just between a woman and her doctor, they're ignoring someone: the unborn child whose life hangs in the balance.
